

From Your GNHOA President

May 2023

I hope everyone has enjoyed the moisture we've received over the last few weeks without the need to shovel sidewalks. That moisture will help generate good growth for lawns - but it will also help grow weeds in our yards and enhance vegetation growth in our Common Area that will eventually dry out and become a fire risk later this year.

We have recently experienced two events in our neighborhood that indicate that we have some young folks that need to be watched more carefully. One was a small fire that was started using matches in the eastern end of the Common Area. Luckily, the fire was spotted almost immediately and was in an area where the vegetation wasn't dry, so it didn't spread quickly. If that had happened in August or September, we would have had a potential disaster. The second event was a group of young males that tore the screens off the windows on the front of a home on Pompeii Square. That act was pure vandalism of a type we haven't seen in our area. Both events demonstrate the need for additional vigilance by parents to keep our neighborhood safe and enjoyable

If you haven't already seen work in progress, we are taking out the rotting timbers along the cement path between Jessie Drive and Steinbeck Lane. The project will entail new weed barrier and additional rock. Also planned, with timing dependent on funds availability, is similar work on the path from the lower end of Jessie Drive leading to the bridge across the drainage channel.

We have been working to try to identify the source of the water causing the seepage east of the concrete path in the lower Common Area and are working with a resident engineer to implement corrective action. That area has also seen issues with basement flooding along Jessie Drive. Academy School District 20 is in the process of inspecting the underdrain system that was installed to take water from the Antelope Trails site across to an area south of Jessie Drive that hasn't been moving water to the intended site. The district has contracted with Olson Plumbing to do the inspection and we will hopefully find out soon whether there is an issue with that system or that we are simply experiencing a change in the migration path of water into our area.

GNHOA has experienced significant cost increases in every aspect of our operations. At our meeting in April, we voted to increase the 2024 annual assessment for operations by \$25, from \$50 to \$75 per year. You will see the increase on the January 2024 invoices when our annual assessments, including the assessments for projects and the stormwater repair contingency fund, will total of \$125 per year - still among the lowest in our area for associations with property to maintain. We are committed to reducing our costs wherever we can, and recently switched our association policies to American Family Insurance to avoid a budget-busting increase in premiums from our previous carrier. The newsletter sponsorship program and the upcoming resident database will allow us to save on mailing costs by sending newsletters and, eventually, invoices by email rather than snail mail.

Elsewhere in this newsletter you will find information about this year's Clean-Up Weekend on June 10-11 and the chipping day on May 20th. We had to separate the two events as the fire department is now only providing chipping support on Saturdays. Please review the restrictions on items that the fire department will accept for chipping as it is more restrictive than in the past. As always, your Board members will be supporting those activities and we always welcome resident participation.






