From Your GNHOA President

I hope the crazy weather hasn't caused any problems for you. On our end, we are working out issues with the new snow removal contractor and would appreciate any comments on future performance to help fine tune his efforts. We erred in not clearing the first light snowfall as it occurred when school was not in session and was less than our typical call-out amount. Our mistake was in not looking ahead after the first light snowfall as the extremely cold weather, rather than our usual warm-up, allowed that snow to freeze on some of the trails and areas of the concrete walkways. The next snowfall then didn't allow full clearing of the walkways as the snow removal ATV could only scrape off the new snow.

The groundwater seepage issue has expanded to another spot on a trail just west of Gleneagle Drive and we are now awaiting an inspection of a drain that was put in to divert water from the wetlands on which Antelope Trails Elementary was built. Since that drain hasn't been emptying any water into the area designated to replace the wetlands, we suspect there may be a blockage that is causing the water to divert into the Common Area and may also be the cause of problems some of the residents on Jessie Drive west of the school are experiencing.

The Board of Directors approved a new Rule at the February meeting that lays out ground rules for rental properties. The Rule is now posted on our website under the Documents tab. In short, the Rule cites the sections of your covenants that address appropriate property uses and then establishes rules for length and type of rentals. If you are renting your property, we would ask that you read the new Rule and, if you have any questions, contact your Filing Architectural Control Representative.

As a reminder, we are on the verge of kicking off data collection for our resident directory for use in providing newsletters, alerts, and necessary owner contacts. We want to assure you that the directory will be used exclusively by the Board of Directors. You will be receiving a notice in the mail instructing you on how to access the online form on our website. That form will ask you if you want to receive your semi-annual invoice and quarterly newsletters by email. Being able to use email for distribution will be a huge cost saver for GNHOA as it costs us over \$400 to mail each newsletter and almost \$500 to mail out each set of invoices. Those funds can be better spent on area improvements and to offset the increasing costs of operating the association, so we ask that you participate in this effort.

Upcoming activities are the annual Shred-It Day on April 1st (this is not an April Fools post) from 9 to 11 am. The annual Clean-Up Weekend dates have not yet been set. We will do the chipping of brush and tree limbs as a separate, one-day, drive-up event as that is the preferred method for the fire department. We will post the dates and times for the chipping day and Clean-Up Weekend on our website's home page as soon as the dates are confirmed.
