We welcome Rich Johnson of Filing 4 as Mark's replacement in the At-Large Director's position. Rich was elected at the Annual Meeting held October 18th. As always, winners will receive gift cards and the top winner in each filing will receive a credit on their electric bill. December also features the Annual Christmas Lights tour. It will be held on December 17th. Details on how to register for the tour are found elsewhere in this newsletter.

Seems that Old Man Winter is trying to make up his mind about when to start this year. With two snowfall events behind us already, it is time to remind everyone that snow should be removed from sidewalks within 24 hours after the snowfall ends and throwing that snow into the street is technically illegal. We realize that the plows sometimes undo your clearing efforts and I have already reached out to Holly Williams, our County Commissioner, to ask that she have the supervisor remind the drivers to slow down and not try to clear the roads all the way to the curb.

You will see a \$12.50 increase in your assessment on the January invoices. We finally had to increase the annual assessment by \$25 to cover our basic operational costs with maintenance of the Common Area being the primary driver. Even with the increase, we have one of the lowest operations assessments in our area, even when compared to those HOAs that do not have a Common Area to maintain.

In the GNHOA Annual meeting in October, the financial reports from fiscal year 2022-2023, spanning Oct 1 - Sep 30, were presented along with the Board-approved budget for fiscal year 2023-2024. If you were not able to attend the meeting, please take a few minutes to review the financial reports and the meeting presentation which are posted on the GNHOA web site at https://gnhoa.com/Documents. I am happy to answer any homeowner questions about Association finances - just email me at treasurer@gnhoa.com.

The Board did approve a \$25 increase to the annual operating assessment for the new fiscal year due to higher costs in several areas. Note that the revised billing amounts for the upcoming Jan 2024 billing cycle will be \$142.75 for assessments and mandatory trash service only, or \$178.00 with the optional recycling service. Please update your scheduled payment records accordingly. For those who opted for the new email-based billing notifications starting in Jan, please allow emails from addresses *_gnhoa.com and quickbooks@notification.intuit.com in your email application to prevent our messages from being filtered as spam/junk.
