From Your GNHOA President

Well, we finally got a dose of Colorado Winter. The snowfall made everything look nice and white for a few days. It also revealed that many of our residents are unaware of a couple of requirements that, although they have been around for some time, haven't been widely advertised so many aren't aware of them. First, the State of Colorado requires sidewalks and driveways be cleared of snow within 24 hours of the end of the snowfall. This is especially important in our area as many of our children walk to school and there is a steady stream of folks walking for exercise, either for themselves or for their dogs. Second, El Paso County prohibits moving snow off your property into the street. That means snow on your sidewalks and driveways needs to go into your yard, not into the street. I know that brings up the issue of the snowplows throwing snow onto the sidewalks and, while I'm pretty sure no one is going to object to moving that snow back off the curb, throwing it into the middle of the street just prolongs the melting process for the traffic lanes. The County guidance does appear to allow you to clear the snow off the street in front of your driveway but asks that it not be put into a big pile that will explode when the plow hits it. Please ensure that you have someone lined up for snow removal if you are away from home.

GNHOA is gearing up for springtime activities and the information on our annual Clean-Up weekend and Shred-It Day are found elsewhere in this newsletter. Another little-known El Paso County requirement that we just discovered is that dumpsters are not allowed to be placed in the street, they must be in your driveway or yard and not blocking the sidewalk. For those who have a short driveway, it may mean a smaller dumpster than the contractor may want to use.

Our contractor is nearing the finish line on repairs to the stormwater drainage channel and lower retention pond area but won't be able to finish up until spring. We do appreciate everyone's avoidance of the areas where work is being performed. By the time you read this, the pond should be full again and ready for the ducks to return (but not the beavers).

In today's digital world, most of us are used to getting information like this newsletter delivered to our inbox. It costs us about \$1,600 per year to print and mail these newsletters—that being said, we will be developing a database of email addresses to use for newsletters and other occasional notices of importance to the community. This database will replace our Alerts program and the 258 of you who are currently signed up for Alerts will have to register again as those email addresses aren't tied to residence addresses. We will also be asking for one or more phone numbers that we can use to contact you if you need to be made aware of an issue requiring immediate attention, such as water coming out of a second-story window. The information we collect is for our internal use only and will not be provided to any outside agency. Please watch your mail for a postcard announcing the creation of the data base and instructions for submitting your information through our website.

After reviewing proposals from several local service providers, the Board agreed that continuing our partnership with GFL Environmental was the best option. The slight increase in service costs was reflected in bills mailed to homeowners in early January. Costs and services are expected to remain the same for the duration of the five-year agreement.

Homeowner payments for January's semi-annual billing are due by March 2. Payment methods currently accepted are checks mailed to GNHOA, scheduled payments through bank online bill pay services, and the newer Zelle EFT payment option (submit Zelle payment to "treasurer@gnhoa.com").
