# **BOARD OF DIRECTORS' CORNER**

Hello Fellow Residents,

The warmer weather will be coming soon, which will no doubt signal the start of the outdoor season for projects and activities. If you are planning to change your landscaping or paint the exterior of your home, make sure you contact your filing Architectural Committee for review/approval of your plans. They are not here to get in your way, only to help maintain the integrity of our community. Speaking of projects, in the coming months you will also notice two community improvement projects at work. The big news came in November when the County DOT was able to provide the matching funds to our approved grant for a sidewalk extension along Gleneagle Drive from Jessie to Wuthering Heights. We are working with the County DOT on the details of construction project, which we expect to begin once school is out for summer. As we mentioned in earlier newsletters, we have been working with the County DOT to upgrade all of our street signs to the new larger letters with better reflection. The County DOT agreed to produce all new street signs if the HOA would install them, keeping the wood poles instead of the metal poles. We have received the new signs and installation will occur in the next few months as the weather permits. If you notice a street sign is missing, contact the HOA first. Our monthly meeting will be moving to the Wescott Fire station for the summer months until the school reopens. Thanks again for your support and cooperation.

## Treasurer's Notes

2015 1<sup>st</sup> Half Annual Assessments, 1<sup>st</sup> Half Trash Assessments, and Way Green Service were due by February 28, 2015 before late fees were charged. Thank you to all the homeowners who sent their timely payment. For those who missed the first due date, second notices with late fees added are being sent. Please inform the Association of any mailing address changes or if you rent your property so statements can be mailed to the correct address.

Trash Collection Update

Please have your trash and recycle barrels placed on the street curb by 8:00am on Mondays. Just a reminder that trash will be collected on Memorial Day, May 25th. Way Green Recycle Service is optional to any homeowners who want the service. For any homeowner wishing to initiate the recycle service, you can do so by contacting the HOA at 488-5883. If you sell your home or move and rent it, you do not need to cancel service or call to start/transfer service. You should contact the HOA to cancel or start Way Green Recycle Service only. The Bestway barrel should stay at the home for the next homeowner or renter.

## Electronics Disposal & Recycling

As of July 1, 2013, Colorado residents are no longer able to send their electronics to a landfill. State law prohibits the disposal of TVs, computers, display devices, AV equipment, and other electronics in local landfills. You can recycle/dispose of these items at the El Paso County Household Hazardous Waste facility (719) 520-7878 along with other hazardous materials. It is a drive-through system that only takes minutes to unload. There are also local electronics recycling events in the Colorado Springs area. Blue Star Recyclers (719-597-6119) also handles electronic recycling for a small fee.

It's that time of year again when we find ourselves buried in old paperwork, cancelled checks, and other financial documents that we need to shred. The GNHOA can help! We have contracted with Federal Document Shredding to provide a FREE shredding service to the GNHOA membership! On April 11th from 10:00am to 12:00pm, rain or shine, a portable shredding truck will be at the north parking lot of the Antelope Trails Elementary School off Copperfield Drive. ### Spring Clean-Up - May 16 and 17

GNHOA is sponsoring the Annual Spring Clean-Up the weekend of May 16th and 17th. There will be six dumpsters placed between the homes of 15185 and 15195 Jessie Drive on the Greenway Access Road. Tires and hazardous liquids (such as paint) may NOT be tossed into the dumpsters. A Way Green Recycle container will be available for glass, plastic, paper, and cardboard. Additionally, a METAL ONLY recycle dumpster will be available. Large appliances can be placed in the metal recycle dumpster. We are coordinating with the Wescott Fire Station to help with tree/branch shredding for homeowner fire mitigation efforts. We will have a GNHOA representative present to assist in off-loading, separating, and "packing" the dumpsters for maximum usage. We have yet to completely fill all of the dumpsters, so there is no reason to be early or use the dumpsters after dark. Please be considerate to the homeowners in the area of the dumpsters. Please do not leave trash at the site before the dumpsters arrive or overfill them.

## Greenbelt Storm Damage Repairs



The September 2013 storm caused some significant damage to the drainage system and culvert crossing in our greenbelt area. We have been working with the County to possibly offset some of the cost of repairs through grants verses HOA special assessments or the use of our HOA reserves. The County assisted us in applying for grant funds in January 2014. While we qualified for some cost sharing, our project was not a high enough priority to execute before the grant funding ran out. We completed our most critical repair: the culvert crossing. The County recently informed us that more grant funding may be available for us to possibly funds a large portion of the remaining repair work. We are waiting for more information and coordinating our needs with them.
