#### **BOARD OF DIRECTORS' CORNER**

Hello Fellow Residents: Here's to hoping we've seen enough of the white precipitation, the start of warmer weather, and the outdoor season of projects an activities. If you are planning to change your landscaping, or paint the exterior of your home, make sure you contact your filing Architectural Committee for review/approval of your plans. They are not here to get in your way, only to help maintain the integrity of our community. Our community improvement project for a sidewalk extension along Gleneagle Drive from Jessie to Wuthering Heights will be starting shortly – weather permitting. A contract between the County DOT and a contractor was signed back in November. Minimal construction impacts along Gleneagle is expected. See note below for Steinbeck Lane closure.



The grants to repair greenbelt drainage damaged in September 2013 are still in the approval process. We must be patient when it comes to obtaining grants to help improve our community. With the completion of replacing all the street signs in the community, please contact the HOA first if one is damaged or missing. Our monthly meeting will be moving to Wescott Fire Station for the summer months until the school reopens. We're looking for volunteers to jion the BoD. Thanks again for your support and cooperation.

Special Note: Steinbeck Lane will be closed for construction to replace the culvert at the Gleneagle Drive intersection from April 18-Apr 29. Homeowners will have to use Wuthering Heights for access to Steinbeck. Check signage and web page for updates

#### Selling Your Home - Transferring Bestway Services

The title company contacts GNHOA on all home sales to get the information on assessments in order to properly prorate our Assessments between the seller and the buyer. If you are currently signed up for the Way Green Recycling Service, when contacted, we ask the title company if the buyer wants to continue recycling. If the buyer does not want recycling, then it is the seller's responsibility to contact the HOA to schedule termination of the recycling service, have Bestway pick up the recycle barrel, and the HOA to provide an accurate statement to the title company. Please help us (and yourself) by asking your realtor to discuss the Way Green Service with the buyer's agent and let us know the answer well before the closing date. Title companies must deliver final closing documents before the closing date, and running down the buyer to get an answer on recycling could delay the closing. The brown Bestway trash barrels should stay at your home, as service is transferred to the buyer automatically.

Over 100 homeowners are currently signed up to receive alerts through their e-mail. Here's how it works: just send an email to GNHOAAlerts@hotmail.com. Your email address will be retained, and added to a distribution list for GNHOA Alerts email notifications. The GNHOA Board greatly respects your privacy, and your information and email address will ONLY be used for the GNHOA alert system. If and when you have some information you feel should be conveyed to your fellow homeowners, (such as criminal activity, etc.), then just email GNHOAAlerts@hotmail.com and the info will be distributed to all of the active participants. This alert system should NOT be used by you to report neighborhood or covenant compliance issues.

# Spring Clean-Up & Shred-It Events



#### Shred-It April 16

It's that time of year again when we find ourselves buried in old paperwork, cancelled checks, and other financial documents that we need to shred. The GNHOA can help! We have contracted with Federal Document Shredding to provide a FREE shredding service to the GNHOA membership! On April 16th from 10:00am to 12:00pm, rain or shine, a portable shredding truck will be at the north parking lot of the Antelope Trails Elementary School off Copperfield Drive. There is no limit to the quantity of document boxes per household. Simply drive up and dump your documents into a barrel, then watch them turn to shreds in less than a minute. #### Spring Clean-Up May 14 and 15

GNHOA is sponsoring the Annual Spring Clean-Up the weekend of May 14th and 15th. There will be six dumpsters placed between the homes of 15185 and 15195 Jessie Drive on the Greenway Access Road. Tires and hazardous liquids (such as paint) may NOT be tossed into the dumpsters. A Way Green Recycle container will be available for glass, plastic, paper, and cardboard. Additionally, a METAL ONLY recycle dumpster will be available. Large appliances can be placed in the metal recycle dumpster. We are coordinating with the Wescott Fire Station to help with tree/branch shredding for homeowner fire mitigation efforts. We will have a GNHOA representative present to assist in off-loading, separating, and "packing" the dumpsters for maximum usage. We have yet to completely fill all of the dumpsters, so there is no reason to be early or use the dumpsters after dark. Please be considerate to the homeowners in the area of the dumpsters. Please do not leave trash at the site before the dumpsters arrive or overfill them. We do ask that you bring your tree and branch debris early to save dumpster space by shredding it early.

Way Green Recycle Service is optional to any homeowners who want the service. For any homeowner wishing to initiate the recycle service, you can do so by contacting the HOA at 488-5883.

## Electronics Disposal & Recycling

State law prohibits the disposal of TVs, computers, display devices, AV equipment, and other electronics in local landfills. You can recycle/dispose of these items at the El Paso County Household Hazardous Waste Facility (719) 520-7878 along with other hazardous materials. It is a drive-through system that only takes minutes to unload.
