

## From Your GNHOA President

August 2021

I hope everyone is enjoying this roller coaster summer of record highs and monsoon downpours. Your Board of Directors has been busy repairing the playset in the toddler playground in the Common Area, orchestrating the dead tree removal program, looking for ways to combat the increasing violations of our covenants, waiting impatiently for the work to start on the stormwater drainage system repairs, and selecting the winners of the Green Thumb Awards.

The tree removal program for residents was once again successful with 28 homeowners participating. There are still enough dead trees in our area that another program may be offered later this year. Please remember that dead trees or bushes constitute an unsightly condition and must be removed.

While the annual Green Thumb Award winners (listed elsewhere in this newsletter) showcase some of the best maintained yards in our area and the rain has helped keep yards green, there are still a few homeowners who are not maintaining their yards. Poorly maintained yards decrease the appeal of our area and negatively impact home sale prices.

In the effort to reduce the number of violations, the Board and Fling ACCs are currently developing summaries of covenants for each filing that list the provisions that are most commonly violated. The summary provides a quick reference and easier reading. Look for those to arrive in the mail but they will also be posted on our website.

The vandalism to the common area playset was repaired for minimal cost by Board Members, but the big repair project for the damage to the stormwater drainage system is still on hold due to poor weather that wreaked havoc on our contractor's schedule and a medical condition that now has him sidelined until about the end of this month. We understand and sympathize with those of you who are frustrated with the lack of action and the unsightly pile of concrete that will be used to construct the check dams once the channel has been straightened. We are in contract for the work and the contractor is the same one who built the system and did the work on Jake's Lake last year. We know the end result will be quality work and his pricing is so much lower than any other bid we received that we would not have sufficient funds to do the project with another contractor without another special assessment. In the interim, we ask that you avoid the equipment and concrete and be careful walking across the retention dam as the undercut has now caused a sinkhole against the retaining wall.

Area schools will be back in session around the week of August 16. Please add more time to your commute for the safety of all. There will most likely be new families, school buses, and car lines in your path. Please be kind and add more time.

Please watch for the announcement of the October annual meeting to arrive in the mail early in September. We don't know yet whether we will hold the meeting in person or virtually or where the meeting might be held. The announcement will contain all the details and voting proxy cards and the information will be posted on our web site home page as soon as we can nail it down.

### Treasurer's Notes

Greetings Homeowners,



We hope everyone is having a great summer and enjoying the beautiful Colorado weather!

You are likely aware that GNHOA coordinates trash and recycling services for the community through a central contract, negotiated by the Board of Directors, with charges in your billing statements every January and July. This common service agreement has reduced homeowners' waste management costs and minimized traffic in the neighborhood with single-day pickup on Mondays for all GNHOA homes. Our current three-year service contract with GFL Environmental (originally Bestway Disposal) expires on Dec 31, 2021. We are planning to request and evaluate proposals from various local service providers in the Sep - Nov timeframe so that we have a new contract in place by end of the year. The Board is seeking two community volunteers to assist several Board members with defining service requirements and reviewing proposals from service providers.
